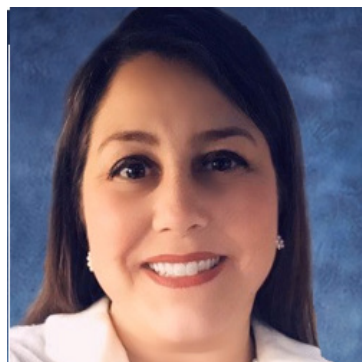

Looking Back at Our Children and Teen Program



2022 saw a return to in-person programming for the children and teens including the popular “**Christmas in July**” party complete with gifts, crafts, games and foam machine!



Families came together in 2022 for a variety of **Activity Nights** including Gingerbread House creations to increase family communication, make connections and reduce stress.



Summer camp for children ages 4 to 12 was held in June and July. Campers enjoyed games, crafts, sports, water activities, and more all while connecting with other children dealing with a cancer diagnosis in their lives.

Children and teens received backpacks full of supplies at our August “**Back to School**” party!



Kid Support™ and **Teen Support** are free peer support groups for kids 4 to 17 who have cancer or who have a parent or family member with cancer. Through these programs the children make friends and learn vital coping skills to manage stress and anxiety.

Resilient Parenting program developed by the University of Arizona was added in 2022. This program focuses on self-care, strengthening family bonds, active listening, and effective rules to supporting children coping with cancer in their lives.

CSCGP had over 2,000 visits to our children and teen program in 2022!

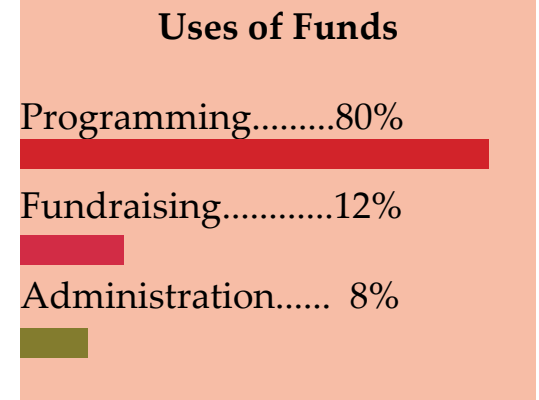
